Skill Sheets

Electrocardiogram (ECG) in Neonates

Indications for when neonates may require an electrocardiogram include cyanosis, tachypnoea, increased respiratory effort, abnormal heart rate or rhythm, a Brief Unexplained Resolved Event (BRUE), feeding difficulties or when screening for congenital cardiac abnormalities.

1 GATHER EQUIPMENT

Gather ECG machine and ECG electrode stickers.

2 > Prepai

Explain the procedure and gain verbal consent.

3

Attend to hand hygiene. Due to the limited body surface of neonates you may need to cut ECG electrodes in half.

Enter patient demographics into ECG machine.



PROCEDURE

Position the neonate in the supine position with chest exposed. Where able, conduct the ECG in a cot with overhead heating to reduce heat loss from exposure.



Attach cords to corresponding electrode. See diagram on page 2 for placement details.

ALERT

Ensure the patient demographics are correct. Some ECG machine models patient data may be retained from a previous patient. Be sure to check the patient information screen for each new patient. Data assigned to the wrong patient can adversely affect diagnosis and treatment.






Procedural Distress

Consider the use of sucrose for reducing discomfort or distress by procedure. Refer to Sucrose 24% Skill Sheet for more details.

Capture ECG when the neonate is lying quietly and there is a clear trace with minimal artefact.



9

Consider leaving electrodes in place and cords in place. Cover the neonate in a wrap for warmth and leave with caregiver supervision.



10

Ask a medical officer to review the ECG. Post medical officer review, remove cords and electrodes. If available, use adhesive remover wipes to assist.



11

Ensure neonate has been reclothed at the completion of ECG collection.
